

## **Costco ANZ 2025 Spend \$130 receive \$30 Shop Card**

### **Promotion Terms and Conditions**

1. Information on how to enter and the prize(s) set out in all communication regarding this promotion (the "Promotion") form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. Any entry not complying with these Conditions of Entry is invalid. Entry into this Promotion and the acceptance or receipt of a prize by any person is deemed as acceptance of these Conditions of Entry.
2. The Promoter is Procter & Gamble Australia Pty Ltd (ABN 91 008 396 245) of Level 4, 1 Innovation Road, Macquarie Park NSW 2113, telephone: 1800 028 280 (the "Promoter").
3. The Promotion commences 10:00AM AEST, 9<sup>th</sup> of June 2025 and closes on 6pm AEST, 6<sup>th</sup> of July 2025 ("Promotional Period"). All entries must be submitted between 10:00am AEST, 9<sup>th</sup> of June 2025 and 11:59 AEST, 20<sup>th</sup> of July 2025 ("Redemption Period").
4. In order to be eligible to participate in the promotion, eligible participants ("Participants") must meet the requirements set out below. Participants must:
  - a. be residents of Australia or New Zealand; with a valid Costco Australia or Costco New Zealand membership number;
  - b. be 18 and over to enter the promotion and further, read and consent to these Terms and Conditions; and
5. To be eligible to enter, individuals must purchase, in a single transaction, \$130 (receipt price after promotions) worth of selected P&G ranged items in Costco AU (including Costco Online) and Costco NZ (excluding Costco Online) during the program window.

Entrants must have completed the claim at ([pgpromo.campaign.net.au/costcoanzshopcard](http://pgpromo.campaign.net.au/costcoanzshopcard)) and submitted the fully completed form during the Redemption Period. Each entrant will then be notified within five (5) business days whether or not entrant has qualified for the \$30 Costco Shop Card. From date an entrant is approved, entrant to receive the \$30 Costco Shop Card within fourteen (14) business days
8. There is a limit of:
  - a) two (2) entries per Costco membership total duration of the promotion; and
  - b) two (2) entries permitted per transaction and per receipt; ie spend \$260, receive 2 x \$30 Costco Shopcards
9. Each entry must be submitted separately and in accordance with entry requirements. Unrecognised receipts will be deemed invalid and will not be accepted.
10. Entrants must retain the original purchase receipt(s) for all entries as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of ALL of an entrant's entries and forfeiture of any right to a Costco shop card. Purchase receipt(s) must clearly specify the store of purchase is a Costco and that eligible P&G products were purchased during the Purchase Period but prior to entry.

12. Receipts with products, amounts and purchase dates that do not qualify will be rejected, and a Costco shop card will not be distributed.
13. The Promoter reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion.
14. The Promoter reserves the right to disqualify any entrant submitting an entry which, in the opinion of the Promoter, includes objectionable content, including but not limited to profanity, nudity, potentially insulting, scandalous, inflammatory or defamatory images or language.
15. The Promoter and/or its agency may require the prize winner(s) to provide proof of identity, proof of age and/or proof of residence as a condition for claim of prize(s).
